Introduction to the role:

The Fermanagh Trust working in partnership with Cavan County Local Development are working together to support communities and citizens make a positive contribution to people's lives and the environment through a new Community Climate Action initiative. With the support of the International Fund for Ireland we plan to implement an ambitious programme of work initially over the next two years. This is an exciting initiative with significant potential for local communities now and into the future.

The office base for the role is Fermanagh House in Enniskillen however much of the work will involve working across Fermanagh and Cavan. The Fermanagh based Coordinator will work very closely with the Cavan Community Climate Action Coordinator developing and delivering a range of cross border initiatives.

Key Duties and Responsibilities

The key duties and responsibilities of the Community Climate Action Coordinator are as follows:

- Target and animate Community and Voluntary Organisations and citizens on a cross-community basis in County Fermanagh and in Cavan in the area of Climate Change.
- Recruit and support citizens to undertake climate leadership and climate action training to become Climate Action Leaders/Champions who will identify and drive climate action activity in their local areas.
- Support the development of Local Community Energy initiatives.
- Develop a plan of action to respond to the needs identified by the Climate Action Leaders/Champions.
- Establish and grow a climate hub in Counties Fermanagh and Cavan as a one stop shop of information and advice for communities.
- Support the development of greater North South collaboration around Climate Change.
- Propose new Climate policy or concepts for consideration on a North South basis.
- Collaborate on an interagency level with other stakeholders including but not limiting to Fermanagh and Omagh District Council, Cavan County Council, Third level and other academic institutions, Government Departments, Community Based Organisations, and the relevant environmental bodies.
- Identify funding opportunities at a national and EU level to grow the climate remit of both The Fermanagh Trust and Cavan County Local Development.

Other

- To undertake any other duties and responsibilities which will assist in the achievement of The Fermanagh Trusts objectives.
- To demonstrate flexibility in the execution of duties as part of a small team.
- To conform at all times to Fermanagh Trust ethics and values.
- To work some evening and occasional weekend hours.
